Consent Agenda Items for Approval

- 8. Resolution 04-20-03 Approval of Extension of Compost It! Yard Waste Collection and Composting Agreement Action for Approval

 Metro Waste Authority entered the initial term of the Compost It! collection agreement in 2017, which was a three-year agreement. The contract allows mutually agreed upon extensions. Waste Management required a 10% increase for all Compost It! yard waste delivered to the compost center at Metro Park East Landfill. As a result, the hauler will be paid \$149.82 per ton for the 2020-yard waste season. Staff recommends approval.
- 9. Resolution 04-20-04 Approval of Change of Metro Waste Authority Principals for Credit Card Banking Services with TCM Bank, N.A. and VISA Action for Approval TCM Bank, N.A. requires a corporate resolution approving the Executive Director as the authorized person to be able to initiate the issuance of VISA cards and ongoing maintenance for our company credit card account. Once approved, the Executive Director will be able to authorize the Finance Administrator and the Accounting Manager to also be authorized to handle maintenance on the account. Staff recommends approval.

Regular Agenda Items for Approval

11. Resolution 04-20-05 – Approval of Water Tanker Truck Purchase for Metro Park West Landfill – Action Item

Metro Park West Landfill uses the water truck to recirculate leachate on site as a primary means of managing the liquid material. The tank on the existing truck is due for replacement at the start of FY 20-21; however, staff has concerns about waiting

to replace due to significant rusting. After researching options, a like-new truck was found for \$127,312. Comparatively, this is about \$50,000 less than the truck purchased in 2011, so it was considered a good value for the organization's needs. Staff recommends approval.

12. Resolution 04-20-06 – Approval of Tanker Trailer Purchase for Metro Park East Landfill – Action Item

Three bids were received for the replacement of the 1990 Walker Tanker Trailer for hauling leachate. The 1990 Walker Tanker Trailer is non-operational due to leaking caused by the rusted frame. The current unit will be evaluated to see if it can be repaired and used as a backup. The recommended replacement tanker is a 2020 Polar XRS Tanker from Seneca Tank for \$61,272.55. The tanker is a non-budgeted item. Funds are available in the Capital Equipment Fund. Staff recommends approval.

13. Resolution 04-20-07 – Approval of Replacement of Metro Park East Inbound Vehicle Scale and Related Accessories and Installation – Action Item After recent scale service and inspection, it was determined that the current decking of the inbound scale is unfit for duty and could fail. There is only one current brand and model that works with the existing concrete foundation construction, for this reason, a single bid was received. The recommended replacement scale is a Mettler Toledo 7531 TRUCKMATE Scale for \$98,000.00, which also includes related accessories and installation by J.A. King Precision Measurement Professionals. The scale replacement is a non-budgeted item. Funds are available in the Capital Equipment Fund. Staff recommends approval.

14. Resolution 04-20-08 - Approval of Trash Cart Purchase for Municipal Solid Waste Programs – Action Item

Four additional member communities expressed interest in Metro Waste Authority (MWA) managing their municipal solid waste contracts. This requires the disbursement of 17,474 carts by July 1, 2020. Rehrig Pacific Company quoted 17,550 95-gallon trash carts for \$850,487.50. Since the communities will likely be added to existing contract(s) through an amendment, and likely for only two one-year extensions, this doesn't allow hauler(s) the opportunity to pay-down their investment in the assets through residents' monthly garbage fees. Instead, MWA will purchase the carts up front and pay down the investment through a small portion of the residents' fees. Then, regardless of what hauler will serve the communities going forward, the MWA carts will remain in place. Staff recommends approval.

15. Resolution 04-20-09 – Approval of Prepayment of the North Dallas Landfill Note – Action Item

Metro Waste Authority (MWA) currently has a loan with North Dallas Landfill Inc. that carries an interest rate of 3.52%. The payments are made on April 20th of each year in the amount of \$200,000. The final payment for this loan is April 20, 2023. As of April 20, 2020, there will be \$560,113 of principal outstanding. If MWA were to pay off the outstanding balance on April 20, 2020, the interest savings would be \$39,886.60. Sufficient funds are available in the unrestricted cash balance to prepay this loan without it negatively affecting MWA's liquidity or other financial requirements. Staff recommends approval.

16. <u>Resolution 04-20-10 – Approval of Metro Waste Authority Executive Director to Set</u> Agency Purchasing Limits

This authorization allows Metro Waste Authority (MWA) Executive Director to adjust employee purchasing limits at any time. Goal is to keep revisions to a minimum and limits will be published once per year for Board review. The Executive Director's purchasing limit of \$50,000.00 has not changed. Staff recommend approval.

Michael McCoy, executive director, reported this resolution is the final step for issuance of the Solid Waste Disposal Revenue Notes. Metro Waste Authority (MWA) has previously held a hearing and all Members have approved a resolution approving the issuance of the notes. Due to market conditions related to COVID-19, this resolution provides parameters with respect to the issuance of the notes, final terms and conditions pursuant to which the notes will be issued. The form of the loan agreement also provides for current provisions and general term covenants related to the issuance. Additionally, this resolution allows MWA to issue the notes in the manner most advantageous without the need for additional Board action.

The loan agreement is proposed to be entered pursuant to authority contained in Chapters 28F and 384 of the Code of Iowa and will be payable solely and only from the net revenues of the MWA.

11. Director's Report

Leslie Irlbeck, deputy director, introduced Metro Waste Authority's (MWA) new Finance Administrator, Joel Etienne, to the Board. Etienne will lead the accounting team and all initiatives around finance and IT. He comes to MWA with experience in the private and public sector.

Michael McCoy, executive director, reported MWA's response to the evolving health emergency, COVID-19. The management team engages in daily calls to discuss operational and personnel needs. Multiple memos have been distributed to staff

regarding return to work protocol, telehealth options, and information on awareness of COVID-19. Each facility has made accommodations to keep customers and employees safe, healthy, and informed.

McCoy reported MWA recently received the Pro Patria Award, the highest award bestowed by the Iowa Committee of the Employer Support of the Guard and Reserve. PJ Gasparovich, mechanic and heavy equipment operator at Metro Park East Landfill, nominated MWA for the Patriot Award that was presented in March 2019. That award qualified MWA for the Pro Patria, and Above and Beyond Award, in recognition of the commitment MWA demonstrated to PJ for and during his service. Receiving this award is an incredible honor for the agency.

ITEM:

Approval of Extension of Compost It! Yard Waste Collection and Composting Agreement.

SUMMARY:

Metro Waste Authority (MWA) contracts with Waste Management (WM) for the collection of yard waste in communities that participate in the Compost It! program.

DISCUSSION POINTS:

MWA entered the initial term of the Compost It! collection agreement in 2017, which was a three-year agreement. The contract allows mutually agreed upon extensions. WM required a 10% increase for all Compost It! yard waste delivered to the compost center at Metro Park East Landfill. As a result, the hauler will be paid \$149.82 per ton for the 2020-yard waste season.

Yard Waste Collection and Composting Agreement (the "Agreement") wherein Contractor agreed to collect, remove and deposit at the MWA facility all collectible residential yard waste material from eligible residences located within the designated collection area for a period of three years from February 1, 2017, through February 1, 2020; and
WHEREAS, the Agreement provides that additional terms can be negotiated upon mutually agreeable terms; and
WHEREAS, the parties have negotiated an additional one-year term with a 10% fee increase.

Approval of Water Tanker Truck Purchase for Metro Park West Landfill.

SUMMARY:

2019 Kenworth T-370 water truck (4,000-gallon tank) with dual cannon and joystick control.

DISCUSSION POINTS:

The water truck is used to recirculate leachate on site as a primary means of managing the liquid material. The tank on the existing truck is due for replacement at the start of FY 20-21; however, staff has concerns about waiting. The truck's tank has a significant amount of rust, so it's best to handle the replacement promptly. After researching options, a like-new truck was found for \$127,312.00. Comparatively, this is about \$50,000 less than the truck purchased in 2011, so it was considered a good value for the organization's needs.

STAFF RECOMMENDATION:

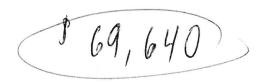

ITEM:

Approval of Replacement of Metro Park East Inbound Vehicle Scale and Related Accessories and Installation.

SUMMARY:

After recent scale service and inspection, it was determined that the current decking of the inbound scale is unfit for duty and could fail. Replacement of the scale is not currently budgeted in the Capital Equipment Fund.

There is only one current brand and model that works with the existing concrete foundation construction, for this reason, a single bid was received:

- J.A. King Precision Measurement Professionals:
 - o Mettler Toledo 7531 TRUCKMATE Scale \$98,000.00

DISCUSSION POINTS:

- The current inbound scale is greater than 10 years old; typical scale life is considered to be 10 years of service.
- Staff contacted the Iowa Department of Transportation (IDOT) to determine who they
 use under State Agreement for Scale Purchasing, Replacement, and Maintenance.
 IDOT also uses Mettler Toledo brand scales and service/installation through J.A. King
 Precision Measurement Professionals.
- Other brands of scales for purchase on the market include Weigh Tronix and Rice Lake; however, these brands will not work with the existing foundation construction. For installation of a brand outside of Mettler Toledo-Model 7531, replacement cost would be higher and require longer closure of the inbound scale.
- Replacement with Mettler Toledo scale by J.A. King comes with a 10 year guarantee, which covers all parts, labor, travel time and mileage costs associated with non-abuse related failure to the scale weighbridge, load receivers, power cells, load cell cables and the weighing terminal.

STAFF RECOMMENDATION:

Staff recommends approval of replacement of Metro Park East Landfill inbound vehicle scale and related accessories and installation by J.A. King Precision Measurement Professionals with Mettler Toledo 7531 TRUCKMATE Scale.

BUDGET REQUIREMENTS:

The scale replacement is a non-budgeted item. Funds are available in the capital equipment budget. The scale will be purchased in replacement of a budgeted Litter VAC Unit and comes in under the budgeted amount by \$25,806.00.

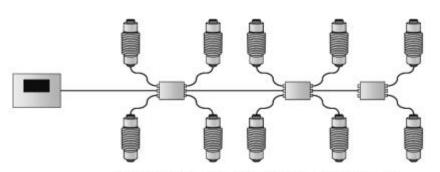

ITEM:

Approval of Trash Cart Purchase for Municipal Solid Waste Programs.

SUMMARY:

Four additional member communities expressed interest in Metro Waste Authority (MWA) managing their municipal solid waste contracts. This requires the disbursement of 17,474 carts by July 1, 2020. Rehrig Pacific Company quoted 17,550 95-gallon trash carts for \$850,487.50.

DISCUSSION POINTS:

MWA branded carts are central to the agency managing the customer service associated with solid waste. The new carts would rollout at the start of a MWA-managed contract, July 1, 2020. Since the communities will likely be added to existing contract(s) through an amendment, and likely for only two one-year extensions, this doesn't allow hauler(s) the opportunity to pay-down their investment in the assets through residents' monthly garbage fees. Instead, Metro Waste Authority will purchase the carts up front and pay down the investment through a small portion of the residents' fees. Then, regardless of what hauler will serve the communities going forward, the MWA carts will remain in place.

STAFF RECOMMENDATION:

Staff recommends approval of trash cart purchase for municipal solid waste programs.

BUDGET REQUIREMENTS:

This purchase of carts is a non-budgeted item. Funds are available in the capital equipment budget after reprioritizing organizational needs. The carts will be purchased in replace of a piece of equipment budgeted for \$1,319,473.00.

ITEM:

Approval of Prepayment of the North Dallas Landfill Note.

SUMMARY:

Metro Waste Authority (MWA) currently has a loan with North Dallas Landfill Inc. that carries an interest rate of 3.52%. The payments are made on April 20th of each year in the amount of \$200,000. The final payment for this loan is April 20, 2023.

As of April 20, 2020, there will be \$560,113 of principal outstanding. If MWA were to pay off the outstanding balance on April 20, 2020, the interest savings would be \$39,886.60.

DISCUSSION POINTS:

There are two factors we are considering with the recommendation of prepaying this loan:

- 1. Simplifying the loan agreement with Polk County. With MWA planning to issue new debt via Polk County, as well as refund the Taxable 2014 Notes, the loan Agreement between MWA and Polk County is simplified by removing the North Dallas Landfill Inc. loan.
- 2. Recently MWA has earned 1.80% on its short-term cash and investments, and with the Federal Reserve cutting short term rates to 0.00% to 0.25%, those interest earnings are likely to reduce further. It makes economic sense for MWA to prepay this debt. MWA will recover these savings over the next three years.

STAFF RECOMMENDATION:

Staff recommends the approval of prepayment of the North Dallas Landfill Note.

BUDGET REQUIREMENTS:

Sufficient funds are available in the unrestricted cash balance to prepay this loan without negatively affecting MWA's liquidity or other financial requirements.
