February 2020 Financial Statements

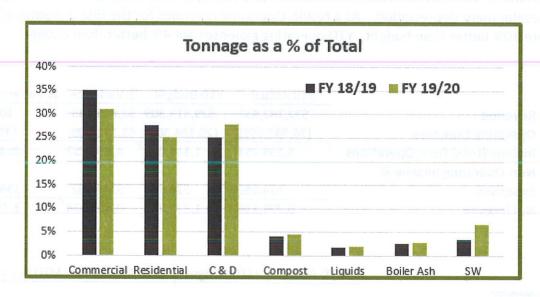
For the month ending February, 2020, Metro Waste Authority has achieved YTD net income of \$5.8M versus \$4.6M prior YTD and a budget of \$1.4M. Variance to budget is due to soft budget projections for commercial waste, construction and demo, special waste and under budgeting Cell Development depreciation. As a result, Operating revenues for the first 8 months of this year are 10% better than budget. YTD operating expenses are 4% better than budget.
